Attendance is taken daily by each 1st period teacher. Students answer a question by 11:59 p.m. in Google Classroom that qualifies As being in attendance for that day. Teachers recorde the previous day's attendance in Harmony 3.

Teachers will continue this method of instruction until the corporation meets 161 days of attendance on May 7. Teachers will monitor student performance toward goals and provide necessary reteaching, remediation, and additional support materials to those who are in need of it.
